## CHIC DNA Repository Clinic

The OESCA Health & Research Committee will be conducting a blood collection for the DNA Blood Bank at CHIC. This banking of DNA would be used for future health research. It will be conducted at the Dome Arena show site on Wednesday and Thursday, September 22 & 23. This clinic is like the one conducted at the National Specialty in Minnesota in 2008. ## OFA Thyroid Clinic

Many of you get Hips OFA x-rayed and Eyes CERF'd. Having all three tests sent to OFA would get you your CHIC certification. This certification tells others in your community and your puppy buyer's that you are responsible about and concerned about the health of your Old English Sheepdog. We have arranged a reduced rate for the lab work and the OFA fee. The OFA fee is half price or \$7.50 and if you have submitted other OFA test's in the past Hips, CERF, Elbows, BAER the fee is waived. The cost for the Thyroid test is \$71.00 and includes the shipping and handling. You will be mailed the results of your test. Blood draw is on Thursday only so that we don't ship over the weekend. Bring your dog's registration forms.

**IMPORTANT - TRANSFER** of dogs from regular classes to Best of Breed/Variety Competition (Ch. 11 Section 6, AKC Rules) MUST be made to the Superintendent/Show Secretary at least one half hour prior to the start of any regular conformation judging at this show. TRANSFERS by Junior Handlers from Novice to Open Class MUST be made to the Superintendent/Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show. SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the judging of any Junior Showmanship classes at the show.

**MOVE UP OF DOGS IN OBEDIENCE/RALLY CLASSES** (Ch. 1 Section 16 of Obedience Regulations) The request for a move up must be in writing and presented to the Superintendent/Trial Secretary at least 30 minutes prior to the start of each trial. Move ups for Obedience may be approved, provided the next level class and judge are available and the class has not reached its limit.

**MOVE UP OF DOGS IN AGILITY CLASSES** ( Ch. 1 Sec. 20 of Agility Regulations) must be received by the Trial Secretary ([cgaburri@verizon.net](mailto:cgaburri@verizon.net)) No later than 6:00 PM, Monday, September 13, 2010. Move-ups can be mailed or e-mailed. No verbal move-ups will be accepted. Move-ups on the day of the trial must be received in writing by the trial secretary no later than 1 hour before the start of Judging.

## Notice to Exhibitors

**NO PRACTICING ALLOWED IN RINGS AT ANY TIME.**

**Dogs May Arrive** any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

**Judges Will Not Wait for Any Dog Holding Up a Class.** Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

**All Dogs Present** must be held on leash or confined to their crates except when being judged or when in the exercising ring.

**Entry Fees** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.

**BATHING AND GROOMING IN DESIGNATED AREAS ONLY**

**Hotels in the area are an extension of the Show Site and all AKC rules will apply.**

**Dogs and exhibitors** must be removed from event by 4:00 pm on Saturday.

No smoking in any building per order of Fire Dept.

Class prizes and trophies must be claimed each day of the events. Trophies will NOT be mailed.



## *AKC Code of Sportsmanship*

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsman-ship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
