PLENTY of Crating space will be available in our 50 x100 crating room. Crates may be left overnight; however, neither OESCA nor Countryside Agility will be responsible for any lost or damaged items left at the show site. All crates must be removed at end of the trial.

Health Clinic & Seminar

This year the Health and Research Committee will sponsor DNA tests on **Wednesday, September 16th**. Look for Dr. Michelle Redfern in the free grooming section. Discounted tests will be offered through PawPrint Genetics, and CA tests from NCSU. Persons not attending can take advantage of the special also. Microchips with lifetime enrollment will be available also.

There will be a 1 hour seminar presented by Dr. Marjorie Brooks. Dr. Brooks is one of the researchers working on the Thrombocytopenia Grant, which OESCA has supported. Her topic "Small Spots can mean big trouble for dogs with autoimmune disease". She will cover the signs and symptoms for the disease, typical medical work up for diagnosis of ITP vs. other bleeding disorders. Also discussed will be treatment, and what this research project aims to accomplish and some of the preliminary data. It will be held on **Thursday, September 17 at 2:30pm** after the end of dog judging and before the Annual Meeting.

Food

Directions

To the Host Hotel: From the East I-90 West to Exit 27, State Street. Turn right off ramp. Go approximately 60 ft. to curve in road. Take curve, Schultz Rd. Hotel is on the right.

From the West: I-90 East to Exit 27, State Street. Make a left off ramp. Go about 700 ft. to curve in road, Schultz Rd. Hotel is on the right.

To the Bayfront Convention Center: From the East: On I-90 Take Exit 32. Take PA-290 West; continue straight onto Bayfront Connector 5.3 miles. Turn left onto E. Bayfront Pkwy. Go 1.2 miles. Turn right onto Sassafras St. Ext.

From the West: On I-90 take exit 22B onto I-79 North. Continue onto Bayfront Pkwy. Go 2.3 miles; Turn left onto Sassafras St Ext.

From North or East: Take I-90 toward Erie; Take I-79 N [Exit 22B] toward Erie; Take EXIT 180 toward US-19/Kearsarge. [0.2 mi]; Interchange Rd. becomes Zimmerly Rd. [0.2 mi]; Turn right onto Zuck Rd. [1.2 mi]; Turn right onto W 38th St. [0.4 mi]; 2321 W 38th St. is on the right. Located in Lake Erie Plaza.

From West: Take I-90 toward Erie; Take the **PA-832** exit, **EXIT 18** toward Presque Isle/Sterrettania Rd.; Turn left onto PA-832/Sterrettania Road. Continue to follow Sterrettania Road [4.8 mi]; Turn right onto West 38th Street [1.4 mi]; Continue on West 38th thru the intersection at Zuck Road. 2321 West 38th Street is on the right just past Pacific Avenue.

Notice to Exhibitors

IMPORTANT - TRANSFER of dogs from regular classes to Best of Breed/Variety Competition (Ch. 11 Section 6, AKC Rules) and transfer from Bred by Exhibitor to Open MUST be made to the Superintendent/Show Secretary at least one half hour prior to the start of any regular conformation judging at this show. TRANSFERS by Junior Handlers from Novice to Open Class MUST be made to the Superintendent/Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show. SUBSTITUTIONS of Junior Showmanship dogs must be made at least one half hour prior to the judging of any Junior Showmanship classes at the show.

MOVE UP OF DOGS IN OBEDIENCE/RALLY CLASSES (Ch. 1 Section 16 of Obedience Regulations) The request for a move up must be in writing and presented to the Superintendent/Trial Secretary at least 30 minutes prior to the start of each trial. Move ups for Obedience may be approved, provided the next level class and judge are available and the class has not reached its limit.

NO PRACTICING ALLOWED IN RINGS AT ANY TIME.

Dogs May Arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Judges Will Not Wait for Any Dog Holding Up a Class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

All Dogs Present must be held on leash or confined to their crates except when being judged or when in the exercising ring.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. Entry fees for Obedience and Rally dogs will be refunded for bitches in Heat. \$10 will be retained for expenses. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to, snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including, but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fee will be made.
