**AWARD OF MERIT-** (National Specialty) At the judge's discretion 8 special rosettes may be awarded at National Specialties to individual specimens in intersex competition in recognition of their merit. Best of Breed, Best of Opposite Sex to Best of Breed, Winners Dog and Winners Bitch, Select Dog and Select Bitch are not eligible for this award as their extraordinary merit has already been recognized.

**AWARD OF MERIT-** (Regional Specialty) At the judge's discretion 4 special rosettes may be awarded at Regional Specialties in conjunction with the National to individual specimens in intersex competition in recognition of their merit. Best of Breed, Best of Opposite Sex to Best of Breed, Winners Dog and Winners Bitch, Select Dog and Select Bitch are not eligible for this award as their extraordinary merit has already been recognized.

**NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES**

**VETERAN DOG CLASS, VETERAN BITCH CLASS:** For dogs and bitches 7 years of age and older. Entrants may be altered. The first place dog and the first place bitch that are undefeated are eligible to compete in Best of Breed Competition.

**SHAVED COAT CLASS FOR OES AKC TITLED DOGS** – (National Specialty Only) Rules:

1. Dog must have an AKC title.
2. Class Divided by Sex.
3. Dog may have no longer than 2" of regrowth to the coat on any part of the body, head or legs or will be ineligible for this class. At the judge's discretion or by protest the judge will measure coat length.
4. Spayed and Neutered dogs are not eligible for this class
5. The first place dog and the first place bitch that are undefeated are eligible to compete in Best of Breed Competition.

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES**

(National Specialty Only)

**STUD DOG CLASS:** For Stud Dogs and two of their get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. The owner of the Stud Dog need not necessarily be owner of the Get. Get only to be judged, based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed. Get must be entered in a regular class, Best of Breed competition, or some other non-regular class.

**BROOD BITCH CLASS:** Same as for the Stud Dog except substitute Brood Bitch for Stud Dog and Produce for Get.

**BRACE CLASS (National Specialty Only):** Two dogs of identical ownership. The dogs comprising a Brace MUST be named at the time of entry. In making entries for "Brace Class Only" full particulars MUST be given for each dog on individual entry forms. An entry form for a dog entered in a Regular Class or for "Best of Breed Competition" and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes. "Brace Class." If more than one Brace is entered by same owner, dogs comprising EACH BRACE must be so designated – "Brace No. 1," "Brace No. 2," etc.

*NOTE: As the judge's decision in the Stud Dog, Brood Bitch, Brace and Classes is based on the merits of more than one dog/bitch, no one of the dogs/bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won this class.*

## JUNIOR SHOWMANSHIP COMPETITION

**NOVICE JUNIOR CLASS-**For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE INTERMEDIATE CLASS -**For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**NOVICE SENIOR CLASS-** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN JUNIOR CLASS-** For Boys and Girls who are at least 9 years and under 12 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN INTERMEDIATE CLASS-** For Boys and Girls who are at least 12 years and under 15 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**OPEN SENIOR CLASS-** For Boys and Girls who are at least 15 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

**MASTER CLASS:** (Effective January 1, 2012) For Boys and Girls who are at least 9 years and under 18 years old on the day of the show and who, at the time entries close, have won ten First Places, with competition present, in an Open Class at a licensed or member show. The calendar for this class will be November 1 – October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry without charge, the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

JUNIORS WHO SUBSTITUTE FOR THE ORIGINAL DOG THEY HAVE ENTERED IN THE JUNIOR SHOWMANSHIP CLASSES WITH DOGS THAT ARE NOT ENTERED IN ONE OF THE OFFERED CLASSES AT THIS SHOW MUST REMIT THE JUNIOR SHOWMANSHIP ONLY ENTRY FEE WITH THEIR SUBSTITUTION.

### 4-6 MONTH BEGINNER PUPPY COMPETITION

Entry Fee - \$15.00

The 4-6 Month Beginner Puppy Competition is open to all Old English Sheepdogs that are four months of age and over but under six months of age on the day of the Show. The class will be divided by sex. An AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows.

A Foreign born dog may enter this class if they are registered in the country of origin. All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.

Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay. Dogs may not be exhibited by current assistants and household members of a professional handler.

Exhibitors should open their dog's mouth for examination. If the judge finds it necessary to open the mouth they should disinfect their hands prior to examining other dogs. Judges will comply with the Rules, Policies and Guidelines for Conformation Judges except the speed of judging may be reduced to 20 dogs an hour.

Male puppies without 2 fully descended testicles need not be disqualified or excused but the judge's book must describe the condition and Certificate of Merit points must be withheld.

Dogs must be excused for attacking a person or other dogs.

No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed. The show results and event service fee of \$2.00 per entry must be submitted to AKC Event Operations.

Dealing with Misconduct will be applicable to any person and dog entered at this competition. All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise.

## Old English Sheepdog Club of America Challenge Trophies

The following trophies are open only to dogs owned or co-owned by members in good standing of the Old English Sheepdog Club of America.

All trophies listed as perpetual trophies have been in competition prior to September 9, 1952 and cannot be won outright. Trophies that can be retired through multiple wins are so listed, with the conditions for their retirement. All perpetual and multiple win trophies must be returned to the Secretary of the Old English Sheepdog Club of America immediately after awards have been presented and photographs taken. After certification by an authorized official of the Old English Sheepdog Club of America that the conditions for a multiple win trophy have been met, the trophy will be returned for permanent possession by the certified winner. A permanent memento will be awarded to the winner of each perpetual or multiple win trophy.

**BEST OF BREED-** The Old English Sheepdog Club of America offers as a perpetual trophy, a Club Sterling Silver Punch Bowl known as the Club's Challenge Cup that is offered for competition at each Specialty Show of the Old English Sheepdog Club of America.

**BEST OF OPPOSITE SEX TO BEST OF BREED-** Mr. & Mrs. Louis Baer offers the Silver Plate Dublin Bowl known as the CH Bonnie Blue of Saltbox Memorial Trophy. Multiple win trophy. For permanent possession, it must be won three (3) times by the same owner, not necessarily with the same dog nor at consecutive shows.

Only the highest qualifying score of a dog's qualifying obedience scores will be counted in this event Regular, optional titling and non-regular classes will all count towards this competition.

- Beginner Novice or Pre-Novice: 50% of total score
- Graduate Novice, Pre-Open, Pre-Utility or Versatility: 50% of total score plus 7 points
- A dog that qualifies in both Utility B and Open B will be awarded an additional 5 points
- High in Trial winner will be awarded an additional 5 points
- High Combined Score winner will be awarded an additional 5 points

**RALLY:**

Only the highest qualifying score of a dog's qualifying rally scores will be counted in this event

- Rally Excellent : Total score plus 10 points
- Rally Advanced: Total score plus 5 points
- Rally Novice: Total score

*PREFACE: The sport of purebred dog competitive events dates prior to 1884, the year of AKC's birth. Shared values of those involved in the sport include principles of sportsman-ship. They are practiced in all sectors of our sport: conformation, performance and companion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.*

- Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportsmen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportsmen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sportsman judge judges only on the merits of the dogs and considers no other factors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylaws, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitors.
- Sportsmen welcome, encourage and support newcomers to the sport.
- Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurn any opportunity to take personal advantage of positions offered or bestowed upon them.
- Sportsmen always consider as paramount the welfare of their dog
- Sportsmen refuse to embarrass the sport, the American Kennel Club, or themselves while taking part in the sport.
