

2016 OESCA National Specialty Vendor Concession Contract

The parties to this contract are the Old English Sheepdog Club of America 2016 National Specialty (hereinafter "Host") and _____ (hereinafter "Vendor").

Whereas, host is hosting an Event known as 2016 OESCA National Specialty to occur at the Hickory Metro Convention Center on 9/26/16 – 9/30/16, beginning at 8:00 a.m. each day, and has the right to license concessions to vend at and the during the Event, and

Whereas, Vendor desires to vend _____ at and during said Event, and

Whereas, Vendor has paid Host the sum of \$40 for a space to vend at and during said Event,

Whereas, Vendor agrees to pay the Host the additional sum of \$40 for (1) electrical receptacle at and during said Event, if desired, and an additional \$40 for each additional electrical receptacle desired,

Whereas, Vendor agrees to comply with all Hickory Metro Convention Center rules, regulations, policies, procedures and terms of the contract/rental agreement between OESCA and the Hickory Metro Convention Center,

Now, therefore, the parties agree as follows:

1. Vendor shall have access to the location agreed upon by the parties no less than 1 hour before the Event's commencement for the purpose of setting up Vendor's vending station, goods, and other things necessary and reasonable to vending at the location.
2. Vendor shall not vend any good or services other than those described herein at and during the Event without the Host's written consent.
3. Vendor's vending station shall be no larger than 10x12 feet or taller than 7 feet; shall be clean and orderly and shall comply with all applicable laws and regulations.
4. Vendor's staff may announce the availability of the goods to be vended only while they are within the confines of the vendor's location.
5. Vendor's staff shall be clothed and groomed in a clean, neat fashion and shall conduct themselves in an orderly fashion.
6. No loud music, noise or sound amplification devices shall be used by vendor's staff at the location.

- 7. Vendor shall have access to the location for up to 2 hours after the Event’s conclusion to dismantle and remove all things brought to the location by Vendor. Vendor shall leave the location clean of trash and substantially in the condition it was before Vendor occupied it.
- 8. Vendor hereby agrees to indemnify and hold harmless the Host against any damages or claims that may arise in connection with Vendor’s presence at the Event and Vendor’s activities of any kind.
- 9. Any violations of this contract/agreement by the Vendor will be grounds for immediate termination of this contract/agreement and expulsion of the Vendor from the Event without recourse.
- 10. The Old English Sheepdog Club of America, Inc. Authorized Representatives:
Only the following listed specific representatives of the Old English Sheepdog Club of America, Inc. are authorized to make amendments, changes and/or additions to this agreement. All amendments, changes and/or additions are to be in writing and signed by a specific authorized representative of the Old English Sheepdog Club of America, Inc. and the Vendor.

Only the following listed specific representatives of the Old English Sheepdog Club of America, Inc. are authorized to make commitments, financial or otherwise, on behalf of the Old English Sheepdog Club of America, Inc for the 2016 National Specialty. All commitments, financial or otherwise, are to be in writing and signed by a specific authorized representative of the Old English Sheepdog Club of America, Inc. and the Vendor.
